In pursuance to Directorate of Skill Development J&K Jammu's Admission Notice issued under endorsement No. DSD/401/Trgs/2025/1521-1611 Dated: 08-05-2025, Online **applications forms** are invited from desirous candidates for seeking admission in **Govt. Women ITI Dharmari for the academic session 2025-26/2025-27** in various Engineering/Non-Engineering Trades having duration of Two years/One year courses being run under NCVT/SCVT Schemes with effect from **15th of May 2025 to 30th of May 2025**. The form can be uploaded from **15th of May, 2025**. The academic session shall start from **1st of September 2025**.

The desirous candidates having minimum age of **14 years as on 1st September 2025**, with no upper age bar have to fill up the admission forms available online at ITI admission link (<http://itiadmissions.jkdsd.in>) present on the official website of Directorate of Skill Development J&K i.e. www.jkdsd.org.

The last date for applying online is up to **30th May 2025**. The candidates have to fill up the complete details which include basic details of student like name, parentage etc. and qualification details online in the portal and have to upload the soft copies in .jpg format (with size between 20KB to 300KB) of the following documents online only:

1. Marks Certificate of Qualifying examination
2. Date of birth Certificate.
3. Category Certificate (SC/ST/Ex-serviceman/Physically Handicapped/EWS) if any
4. Aadhaar card.
5. **(*Domicile certificate should be produced at the time of admission in the respective ITI).**

The candidates after finalizing the profile and application online will be required to deposit the printout of the system generated application completed in all respects along with self-attested documents uploaded on the portal and deposit the prescribed fee of **Rs.100/- (One Hundred Rupees only)** for three trades against a proper receipt in **Govt. Women ITI Dharmari**.

IMPORTANT NOTE:-

1. The applying candidate **has to submit printout of system generated application along with requisite self-attested documents at Govt. Women ITI Dharmari.**
2. The candidate shall deposit the @ **Rs.100/- (One Hundred Rupees Only)** for three trades at Govt. ITI Dharmari against a proper receipt.
3. Selection will be made purely on the basis of academic Merit obtained by the applicants in their qualifying examination (both the free and payment (IMC) seats separately)
4. On successful completion of training in trades affiliated under NCVT/SCVT Scheme, Certificate will be awarded by the National/State Council for vocational Education & Training.
5. Candidates, who have already undergone training in any of the trades of ITIs, can apply for admission in another trade two years after completion of previous training course. However, for the ensuing academic session their admission is considered in any of the trades having poor response.
6. **Trainees with an active admission** or those who have already undergone training in any trade at any ITI are not eligible to apply for admission to another trade, and **if a trainee enrolls without disclosing such information, the admission will be considered cancelled.**
7. Selected Trainees should retain a consistent mobile number and e-mail address till completion of course, until certification, as changes are not permitted by DGT.
